## EXPLANATORY NOTE

### Nokia Employee Share Purchase Plan

This Post-Effective Amendment No. 1 to the Registration Statement on Form S-8, Registration No. 333-216908 (the “*2017 Registration Statement*”) is being filed to deregister certain shares (the “*Shares*”) of Nokia Corporation (the “*Company*”) that were registered for issuance pursuant to the Nokia Employee Share Purchase Plan (the “*2017 Employee Share Purchase Plan*”). The 2017 Registration Statement registered 1,500,000 Shares issuable pursuant to the 2017 Employee Share Purchase Plan to employees of the Company. The 2017 Registration Statement is hereby amended to deregister all Shares that were previously registered and that remain unissued under the 2017 Employee Share Purchase Plan.

### Nokia Performance Share Plan 2017

This Post-Effective Amendment No. 1 to the 2017 Registration Statement is being filed to deregister certain Shares of the Company that were registered for issuance pursuant to the Nokia Performance Share Plan 2017 (the “*2017 Performance Share Plan*”). The 2017 Registration Statement registered 15,000,000 Shares issuable pursuant to the 2017 Performance Share Plan to employees of the Company. The 2017 Registration Statement is hereby amended to deregister all Shares that were previously registered and that remain unissued under the 2017 Performance Share Plan.

### Filing Fee Offset

Contemporaneously with the filing of this Post-Effective Amendment No. 1 to the 2017 Registration Statement, the Company is filing a Registration Statement on Form S-8 (the “*New Registration Statement*”) to register shares issuable under other of its employee benefit plans. In accordance with Rule 457(p) under the U.S. Securities Act of 1933, as amended, this Post-Effective Amendment No. 1 to the 2017 Registration Statement is also being filed to carry over to the New Registration Statement the \$9,013.51 portion of the registration fee previously paid by the Company in connection with the 2017 Registration Statement to register 14,550,000 Shares.
